After you have received Unemployment Insurance benefits for ten (10) weeks you must be willing to accept any work that you are capable of doing, whether or not you have experience or training in that kind of work (see New York Labor Law Section 591.2 and 593 for more information). You must also keep and complete a work search record (Online or written) for each week you claim Unemployment Insurance benefits. You must provide a copy of your written record to the Department of Labor upon request.
